NOTES

There is a payment drop provided at the District's Office for payments after hours, on weekends, or on holidays. If the 19th falls on a weekend or a holiday, late charges will apply if payment is not in the office when it next opens for business. If all amounts due and payable, including charges for water usage, late charges, and other fees, are not paid by the last day of the month when due, service will be disconnected pursuant to the district's meter disconnect and reconnect policy as may then be in effect as stated in the Billing Policies and Procedures.

Any account upon which two checks are returned unpaid for any reason within any six month period will be required to pay all future payments with cash, a bank cashier's check, money order, debit or credit card. All checks returned NSF or not paid for any other reason must be promptly picked up with cash, a bank cashier's check, money order, debit or credit card.

There is a **\$25.00** reward for reporting a water leak on R.W.D. #15's lines (not meter leaks), if it has not been previously reported.

For emergencies, call the District's office at 918-396-2552. Please leave your name, number, and nature of the emergency.

¹If an Application for water service and Benefit Unit is to serve property within the District previously served by virtue of a previously forfeited Benefit Unit, and the proposed new service will be through an existing service connection where the only required installation of materials necessary for resumption of service is re-installation of a meter, previously removed following a previous forfeiture, then the Benefit Unit Fee shall be \$1,200.
